RESOLUTION NO. 173

Letter of the City Engineer, Ormoc City, dated November  
17, 1951 to the Municipal Board, Ormoc City thru the City  
Mayor, Ormoc City hereunder quoted verbatim as follows:

Gentlemen:

I have the honor to request the transfer of the appro-  
priation of P8,242.00 from J-27-6(3), Garbage Collections,  
to J-27-6, Maintenance and Repairs of City Streets, in view  
of the fact that the twelve (12) street sweepers have been  
doing work, at the same time, in the maintenance of city  
streets from which their wages have been usually charged.  
There had been an extra gang too employed in the improve-  
ment of Obrero Street charged to this appropriation. With-  
out such transfer, the appropriation under J-27-6, Mainte-  
nance of City Streets will be exhausted by December.

I am requesting also the transfer of P2,000.00 from  
J-71, Land Transportation Equipment, for the Construction  
of Liloan-Balion Vecinal Road.
