Letter of Mr. Roman Hermias, Waterworks Inspector,
Ormoc City dated September 13, 1951 to the City Engineer,
Ormoc City and 1st Indorsement of City Engineer dated Sep-
tember 14, 1951 hereunder quoted verbatim respectively as

I have the honor to submit here-
with the estimate of the expenses from the
main line to the City Slaughterhouse loca-
ted at the end of Lopez Jaena Streets as
follows:

(a) 5 tubes - - - - -	P 52.50
(b) 1 service cock- - -	3.50
(c) 1 union - - - - -	2.00
(d) 3 elbow - - - - -	1.50
	<u>P 59.50</u>

It is requested that funds be secured
immediately as Mr. Guillermo Abaño, owner
of distribution, is complaining as it is
detrimental to their convenience, the
Slaughterhouse draining not their supply
of water.

The Board, on motion of Councilor Felipe Adolfo, seconded by Vice Mayor Marcelo D. Bandalan;






