fertilizer.

Shipment of 1,400 bags of nitrogenous phos-
phatic fertilizer is forthcoming this week, hence
the storage rooms aforementioned are earnestly
requested.


BE IT RESOLVED, as is hereby resolved, to respectfully

the unoccupied room of the Municipal Judge, Ormoc City, at the quonset hut;


