RESOLUTION NO. 182

WHEREAS, on the suggestion of Vice Mayor Marcelo D. Bandalan, requesting Hon. Domingo Veloso, Speaker Protempore, House of the Representatives to make personal representation to secure financial aid from the ECA management and from the discretionary fund of the Hon. Secretary of Public Works and Communication for Barrio Road Construction;

WHEREAS, it is known that the city of Ormoc has not as yet received financial aid from the ECA;

WHEREAS, it is reliably informed that P18,000,000 is set aside by the ECA for the economic development of Mindanao;

WHEREAS, the city of Ormoc is badly in need of ECA aid to fully develop her agricultural potentialities; and in order to carry out her program of agricultural development, it is necessary to construct roads to connect the different interior barrios to the main highway thus giving facility of transportation to the people to settle in the interior sitios and barrios;

WHEREAS, the city of Ormoc is financially unable to carry out her program of barrio road construction without ECA aid;

NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councilor Porfirio Ayuyao;

BE IT RESOLVED, as is hereby resolved to respectfully request Hon. Domingo Veloso, Speaker Protempore, House of the Representatives; Manila to make personal representation with the ECA management in Manila to secure financial aid from the ECA and also from the Discretionary Fund of the Hon. Secretary of Public Works and Communication to carry out the road construction to the interior barrios as follows:
