NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councillor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved, to respectfully request Hon. Domingo Veloso, Speaker Protempore, House of the Representatives, Manila to kindly set aside from his pork barrel fund for the year 1951-1952 the sum of ₱12,000 for the construction of Artesian Wells at ₱1,500 each for the barrio of Linao, Libertad, Lilo-an, San Antonio, Ipil, Macabug, Mas-in, Balion, and Manlilinao;

RESOLVED FURTHER, to respectfully convey to Hon. Speaker Protempore, Domingo Veloso the necessity of providing artesian well for the aforementioned barrios for the reason that the barrio people concern are badly in need of safe drinking water for the protection of their health;

RESOLVED FINALLY, to furnish copy of this resolution each to Hon. Domingo Veloso, Speaker Protempore, House of the Representatives, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; and the City Engineer, Ormoc City.
