With reference to Resolution No. 162, current series, of that Body, I have the honor to advice that the unappropriated balance shown in the Annual Budget for the fiscal year 1951-1952 is \$1,258.55. This balance is even very insufficient to meet the required 5% reserve which is ₱16,378.05.

The wages of the proposed 40 additional policemen at P65.00 each per month from November 5, 1951 to June 30, 1952, will be around \$20,453.33. Even if funds become available thru reversions of appropriations, The Honorable Secretary of Finance will disapprove the supplemental budget for that purpose on the ground that the total appro-priation for salaries and wages would far exceed the amount allowable under Executive

Order No. 405, current series.

This Office, therefore, regrets to state that no supplemental budget can be made now or until sufficient fund is available for the wages of the proposed 40 additional policemen.
