RESOLUTION NO. 165

Letter of Mr. H. I. Modina, Chief Clerk & Deputy,
of the City Treasurer, Ormoc City dated December 6, 1951
hereunder quoted verbatim as follows:

Gentlemen:

With reference to Resolution No.
162, current series, of that Body, I have
the honor to advise that the unappropriat-
ed balance shown in the Annual Budget for
the fiscal year 1951-1952 is P1,258.55.
This balance is even very insufficient to
meet the required 5% reserve which is
P16,378.05.

The wages of the proposed 40 addition-
al policemen at P65.00 each per month from
November 5, 1951 to June 30, 1952, will be
around P20,453.33. Even if funds become
available thru reversions of appropriations,
The Honorable Secretary of Finance will
disapprove the supplemental budget for that
purpose on the ground that the total appro-
priation for salaries and wages would far
exceed the amount allowable under Executive
Order No. 405, current series.

This Office, therefore, regrets to
state that no supplemental budget can be
made now or until sufficient fund is avail-
able for the wages of the proposed 40 addi-
tional policemen.
