Sirs:

I have the honor to request this Honorable Body, that a resolution be passed to the effect that the fund set aside for the traveling expenses of this Department for the fiscal year 1951 in the amount of 2000.00 as specified in the city budget be deducted P52.50 and this amount be added to the fund for the uniform of the personnel of the fire Department, Ormoc City, in the amount of P450.00 which is insufficient to cover up the total amount for the uniform as hereunder stated:

15 suits (Fatigue) at P 20.50 each	P307.50
15 pairs of shoes (Ang Tibay) at P13.00 ea.	195.00
TOTAL	P 502.50

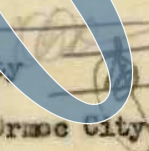
