RESOLUTION NO. 187

Letter of Mr. Basilio Capuyan dated December 8, 1951 hereunder quoted verbatim as follows:

Ormoc City, December 8, 1951

THE MUNICIPAL COUNCIL
Ormoc City
(Thru the City Mayor)

Gentlemen:

Appealing to your sense of justice and spirit of equitable consideration, I have the honor to request that my market stall rental of P135.00 a month be reduced to P100.00 for reasons as follows:

1. That I do not make good business for the present. My daily income is barely enough and sometimes not even enough to meet my average daily rental and running operating expenses:

2. There are now other available market stools where I could transfer and reduce my present rental even by two thirds lower than what I am paying now. I can not help but seek for what is lower for the present in order to make some economic adjustments in order to live.

Since I look upon the government with confidence that it functions largely for the welfare and well-being of its people, I highly hope that this request be given favorable consideration.
