AND WHEREFORE, the Board, on motion of Councilor Antonio C. Cataag, seconded by Councilor Porfirio Ayuyao;

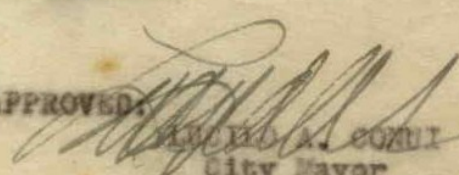

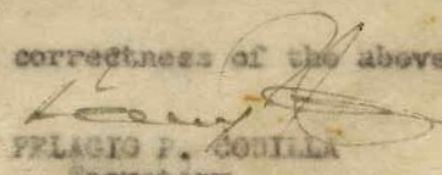
