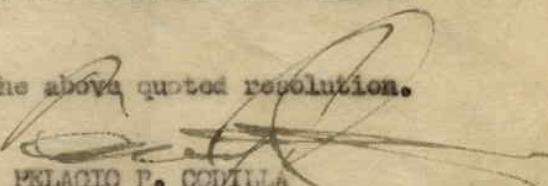
AND WHEREAS, The Board, on motion of Councillor Antonio C. Cataag seconded by Councillor Porfirio Ayuyao;

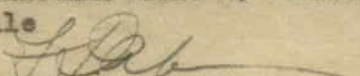
