RESOLUTION NO. 193

WHEREAS, on manifestation of Councilor Guillermo T. Parrilla to temporarily suspend the enforcement of Article One and Article Seven (7) of Ordinance No. 2, otherwise known as Building Ordinance for the City of Ormoc, for Sixty (60) days in order to allow the owners of buildings in Ormoc City to repair their buildings destroyed during the typhoon which lashed the Visayan Island on December 9, 1951;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Flaviano Montesclaros;

BE IT RESOLVED, as is hereby resolved, to temporarily suspend the operation and enforcement of Article One (1) and Article Seven (7) of Ordinance No. Two (2), otherwise known as Building Ordinance for the city of Ormoc for Sixty (60) days in order to allow the owners of buildings to repair their buildings destroyed during the typhoon which lashed the Visayan Islands on December 9, 1951;

RESOLVED FURTHER, that this temporary suspension refers specifically to fees exemption on the repair of their building without prejudice, however, to the requirement of Article One (1) of said Ordinance No. Two (2), to secure permit from the Official concern for such repair;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; City Engineer, Ormoc City and Bandillo for the general public, Ormoc City.
