RESOLUTION NO. 213

WHEREAS, the Municipal Board of Ormoc City submitted on January 15, 1951 for consultation to the Honorable Secretary of Finance, Manila on the subject "Legality on the proposed appropriation of the Municipal Board setting aside funds for per diems of barrio Lieutenants when called for conference by the City Mayor";

WHEREAS, on 1st indorsement dated September 3, 1951, the consultation on the subject was referred to the Honorable the Auditor General, Manila and to the City Auditor of Ormoc City respectively for comment and recommendations;

WHEREAS, the City Auditor recommended for disapproval on the subject for the reason that he is not aware of any provision of law, rule or regulation allowing per diems to the barrio lieutenants;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teloron, seconded by Councilor Flaviano Montesclaros;

BE IT RESOLVED, as is hereby resolved, to request Acting Speaker, Honorable Domingo Veloso, House of the Representatives, Manila to recommend legislation in Philippine Congress to grant a nominal compensation of P1.00 a year to all barrio lieutenants so that barrio lieutenants could be considered employees of the government and therefore entitled to per diems;

RESOLVED FINALLY, to furnish copy of this resolution each to the Executive Secretary, Manila; Honorable Domingo Veloso, Acting Speaker, House of the Representatives, Manila; Honorable Secretary of Finance, Manila; Honorable Auditor General, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City and the City Auditor, Ormoc City.
