RESOLUTION NO. 6

WHEREAS, typhoon "Amy" which has recently passed the Visayas has left in its wake vast devastation to public and private properties in the City of Ormoc;

WHEREAS, most of the public school buildings of the different barrios of Ormoc City have been destroyed in the wake of typhoon "Amy" thereby paralyzing and hampering the education of school children;

WHEREAS, the Parent-Teachers Association of the different barrios of Ormoc City while as always are willing to cooperate are not now financially in a position to give material and financial aid for the rehabilitation of their barrio school buildings for the reason that they, too, have individually suffered from the said destruction of the typhoon "Amy" aside from the fact that the PTA organizations have in the past been heavily saddled with contributions in the erection of these public school buildings;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Ifaki Larrazabal;

BE IT RESOLVED, as is hereby resolved to respectfully request Acting Speaker, Honorable Domingo Veloso, House of Representatives, Manila, to allocate ₱50,000 for Ormoc City out of the ₱150,000 secured by him and upon information of the Presiding Officer, set aside for the province of Leyte, in order to rehabilitate and rebuild the typhoon damaged public school buildings of Ormoc City, the destruction of which have been already reported to be not less than ₱100,000;

RESOLVED FINALLY, to furnish copy of this resolution each to His Excellency, President Elpidio Quirino, Malacañan Palace, Manila; Hon. Sec. of Public Instruction, Manila; Acting Speaker Domingo Veloso, House of Representatives, Manila; Director of Public Schools, Manila; the City Mayor, Ormoc City, City Treasurer, Ormoc City and City Auditor, Ormoc City

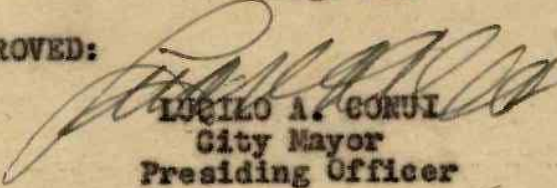

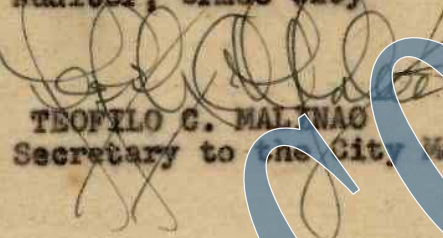
