VETO OF RESOLUTION NO. 8 OF THE
MUNICIPAL BOARD CURRENT SER-
IES PURSUANT TO REPUBLIC
ACT No. 179.

The undersigned hereby vetoes Resolution No. 8 of the Municipal Board, this City, pursuant to Art. 3, Sec. 14 of Republic Act No. 179, for the following reasons:

1. IT IS DISCRIMINATORY. - It is found by the undersigned that the Vice Mayor who is considered to be a ranking member of the Municipal Board is not even a member much least a chairman in any of the standing committees provided for in the said resolution. Reasons to the contrary notwithstanding, the Vice Mayor should at least be given a chairmanship in any important committee if the Board expects him to contribute something tangible and concrete for the interest of public service. His omission is a deliberate intent on the part of the Municipal Board to disregard composition of committees in legislative bodies.

2. The Resolution failed to define and delimit the functions, duties and power of each standing committee which is necessary to determine their respective scope.

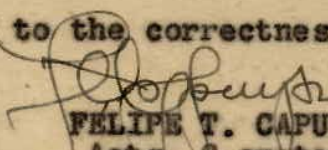
