RESOLUTION NO. 12

OVER-RIDING THE VETO OF RESOLUTION
NUMBER 3 OF HIS HONOR THE CITY MA-
YOR, ORMOC CITY

WHEREAS, the Municipal Board, Ormoc City, in its
Special Session held on January 3, 1952 passed Reso-
lution Number 3 designating Mr. Ramon Bantasan as Se-
cretary to the Municipal Board, Ormoc City vice Mr.
Pelagio P. Codilla;

WHEREAS, Resolution No. 3 further provides for
the continuation of the vacation and sick leave of
Mr. Pelagio P. Codilla and the termination of the
services of the same;

WHEREAS, His Honor, the City Mayor, Ormoc City
has vetoed Resolution No. 3 of the Municipal Board,
Ormoc City, dated January 3, 1952, designating Mr.
Ramon Bantasan as Secretary to the Municipal Board
for reasons stated in the veto;

WHEREAS, Councilor Victorino C. Teleron contended
that the veto power exercised by the Honorable City
Mayor in this particular case is illegal and incon-
sistent with the provisions of Section 13, Republic
Act No. 179, otherwise known as the Charter of the
City of Ormoc;

NOW THEREFORE, the Board, on motion of Councilor
Victorino C. Teleron, seconded by Councilor Alvaro
I. Gutierrez;

BE IT RESOLVED, as is hereby resolved to over-
ride the veto of His Honor, the City Mayor, Ormoc
City of Resolution No. 3 of the Municipal Board,
Ormoc City dated January 3, 1952, designating Mr.
Ramon Bantasan as Secretary to the Municipal Board
