RESOLUTION NO. 19

WHEREAS, the Municipal Board of Ormoc City, in its
Special Session held on January 3, 1952 passed resolution
number 8 creating standing committees of the Municipal
Board of Ormoc City;

WHEREAS, the Honorable City Mayor, Ormoc City, pur-
suant to the provisions of Section 14, Art. 3, Republic
Act No. 129, otherwise known as the Charter of the City
of Ormoc, vetoed the aforementioned resolution for rea-
sons stated in the veto;

WHEREAS, Councilor Alvaro I. Gutierrez manifested
that the Resolution above mentioned does not have in it
the intention to ignore the Vice Mayor but the way the veto
expresses itself is an intention to include the Vice
Mayor as Chairman or member of any of the Standing Com-
mittees created by the Municipal Board;


NOW THEREFORE, the Board, on motion of Councilor


