RESOLUTION NO. 22

OVER-RIDING THE VETO OF RESOLUTION
NUMBER 13 OF HIS HONOR THE CITY MA-
YOR, ORMOC CITY

WHEREAS, the Municipal Board, Ormoc City in its regular session held on January 5, 1952 passed resolution No. 13 abolishing six positions in the Fire Department of Ormoc City;

WHEREAS, the Honorable City Mayor of Ormoc City pursuant to the provisions of Section 14, Art. III, Republic Act No. 179, otherwise known as the Charter of the City of Ormoc vetoed the aforementioned resolution for reasons stated in the veto;

WHEREAS, Councilor Victorino C. Teleron informed the Honorable Body that the six positions in the Fire Department as abolished in the above mentioned resolution are non-essential services;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Ifiaki Larrazabal;

BE IT RESOLVED, as is hereby resolved to over-ride the veto of the Hon. City Mayor of Ormoc City on Resolution 13, of the Municipal Board;

Secretary of Finance, Manila; the Hon. Civil Service Commissioner, Manila; the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; and the Chief Fire Department, Ormoc City.
