RESOLUTION NO. 27

WHEREAS, Councilor Victorino C. Teleron informed the Honorable Body that the barrio school at Valencia, Ormoc City has been destroyed on account of the recent typhoon;

WHEREAS, the District Supervisor of Ormoc District II is at present renting houses at Valencia, Ormoc City for handling classes;

WHEREAS, in order not to impair the education of the school children it is necessary that the Municipal Board of Ormoc City appropriate the amount of ₱1500.00 to be taken from the unappropriated balance of the Annual Fund Budget of Ormoc City, not otherwise appropriated, to pay the rentals of the houses which are being used by the District Supervisor of Ormoc District II for handling classes;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of ₱1500.00 to pay the rentals of the houses, used by the District Supervisor of Ormoc District II, Ormoc City, for handling classes;

BE IT FURTHER RESOLVED, that the amount of ₱1500.00 as above appropriated be taken from the unappropriated balance of the Annual Fund Budget of Ormoc City, otherwise not appropriated.

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City, City Treasurer, Ormoc City; City Auditor, Ormoc City; District Supervisor, Ormoc District II, Ormoc City.
