RESOLUTION NO. 12

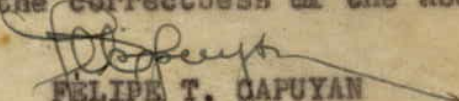
NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Westime Ocubillo,

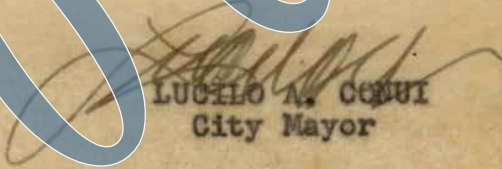
