RESOLUTION NO. 30

WHEREAS, Councilor Iñaki Larrazabal informed the Honorable Body that in the construction of the Patag waterworks there is a surplus in the appropriation in the amount of ₱329.51; in the Donghol waterworks there is also a surplus of ₱162.27 and in the Del Carmen Waterworks a surplus of ₱24.52, making a total of ₱516.30;

WHEREAS, the above surplus amount of ₱516.30 shall be reverted to the General Fund of Ormoc City and then be again reverted to the Extension of the Waterworks System from Nadongholan to Cantubo District, Ormoc City;

NOW THEREFORE, the Board, on motion of Councilor Iñaki Larrazabal, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved that the the surplus amounts in the construction of the Patag Waterworks, Donghol Waterworks and Del Carmen waterworks which would make a total of ₱516.30 be reverted to the General Fund of Ormoc City;

BE IT FURTHER RESOLVED, that the amount of ₱516.30 as above reverted to the General Fund of Ormoc City, be again reverted to the Extension of the Waterworks System from Nadongholan to Cantubo District, Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the City Engineer, Ormoc City.


