RESOLUTION NO. 33

WHEREAS, Vice Mayor Marcelo D. Bandalan informed the Honorable Body of the necessity of a T-D 14 tractor with dozer in the Engineering Department of Ormoc City;

WHEREAS, the use of a T-D 14 tractor with dozer in the Engineering Department of Ormoc City would greatly reduce the employment of laborers for the construction and repair of roads, thus effecting economy;

WHEREAS, in order to procure a T-D 14 tractor with dozer, the City Engineer, Ormoc City shall be authorized to purchase said tractor with dozer from the N.D.C., Palo, Leyte, and the ₱10,000 appropriated for the purchase of a Station Wagon for the City Engineer which has been reverted to the Roads and Bridge Fund of the Engineering Department be appropriated for the purchase of said T-D 14 tractor with dozer;

NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councilor Iñaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to authorize the City Engineer, Ormoc City, to purchase a T-D 14 tractor with dozer from the N.D.C., Palo, Leyte;

BE IT RESOLVED FURTHER, that the amount to be appropriated for the purchase of said tractor be taken from the ₱10,000 appropriated for the purchase of a Station Wagon in the Engineering Department of Ormoc City which has been reverted to the Roads and Bridge Fund;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the City Engineer, Ormoc City.




