RESOLUTION NO. 46

WHEREAS, Councilor Usualdo F. Laguitan informed the Honorable Body that some of the public school buildings of District I, Ormoc City and the buildings of the Ormoc City High School have been destroyed on account of the recent typhoon;

WHEREAS, the District Supervisor, Ormoc District I, and the Principal, Ormoc City High School, are renting houses for handling classes;

WHEREAS, in order not to impair the education of the school children, the Municipal Board, Ormoc City shall appropriate the amount of P1,700 to pay the rentals of the houses presently used by the District Supervisor, Ormoc District I and the Principal, Ormoc City High School for handling classes;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P1,700; P1,000 for District I, Ormoc City and P700 for Ormoc City High School, Ormoc City to pay the rentals of the houses presently used for handling classes;

BE IT FURTHER RESOLVED, that the amount of P1,000 as above appropriated for District I, Ormoc City, be taken from C-77-5(1); and that the amount of P700 as above appropriated for Ormoc City High School be taken from C-36-t;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; District Supervisor, Ormoc District I and the Principal, Ormoc High School, Ormoc City.
