RESOLUTION NO. 43

WHEREAS, Mrs. Enriqueta I. Maribao, Nurse, Ormoc Puericulture Center and Maternity House, in her letter, (not dated) addressed to the Municipal Board, Ormoc City, requested the Honorable Body to appropriate a certain amount for the salary of an additional attendant at the rate of ₱50.00 per month;

WHEREAS, the Ormoc Puericulture Center and Maternity House has at present only one attendant who cannot cope with the work to be done;

WHEREAS, to enable the Ormoc Puericulture and Maternity House to render a better and effective service to the community it would be necessary to add one attendant as requested by the Nurse of said Puericulture Center and Maternity House;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Esteban C. Conejos;

BE IT RESOLVED, as is hereby resolved to approve the request of Mrs. Enriqueta I. Maribao, Nurse, Ormoc Puericulture and Maternity House for an additional Attendant at the rate of ₱50.00 per month; effective February 1, 1952;

BE IT FURTHER RESOLVED to appropriate the amount of ₱250.00 for the salary of said additional attendant from February 1, 1952 to June 30, 1952;

BE IT RESOLVED FURTHERMORE, that the amount as above appropriated be taken from any unappropriated balance of the Annual Fund Budget of Ormoc City, otherwise not appropriated;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and Mrs. Enriqueta, I. Maribao, Nurse, Ormoc Puericulture and Maternity House, Ormoc City.
