RESOLUTION NO. 49

Letter of Mr. Francisco Arradaza, Market Superin-
tendent, Ormoc City, dated February 6, 1952 and 1st In-
dorsement of Mr. H. I. Modina, Chief Clerk & Deputy,
Office of the City Treasurer, Ormoc City, dated February
9, 1952, hereunder quoted verbatim respectively as fol-
lows:

The Honorable Municipal Board

Sir:

I have the honor to inform you that there are two
stalls in the Public Market having no exits, Nos. 34
and 54. These stalls can be utilized only as bodegas.

By this reason I would suggest that the rental of
said stalls be reduced to thirty five centavos (P.35)
daily, exempting market fees.

This will attract adjoining stall occupants to
acquire above mentioned stalls.
