RESOLUTION NO. 53

WHEREAS, Councilor Esteban C. Conejos suggested to the Honorable Body to appropriate the amount of P1,500 for the extension of the Ormoc Waterworks System to the Pier; to furnish water facilities to boats docking at the pier;

WHEREAS, the extension of said waterworks system to the pier would add more income to the city government of Ormoc City;

WHEREAS, Councilor Esteban C. Conejos further suggested to the Honorable Body to appropriate the amount of P400.00 for the completion of Hibonawon Waterworks System and P188.00 for the completion of the Nadongholan Waterworks System;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Iñaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P2,088.00 for the accomplishment of the following projects, viz:

P1,500 for installation of waterpipe connection to the pier
400. for the completion of Hibonawon Waterworks
188. for the completion of Nadongholan Waterworks

BE IT FURTHER RESOLVED, that the amount of P2,088.00 as above appropriated be taken from the following items, viz:

P 88.00 from C-77-1 - Office of the City Mayor
500.00 from C-79-2 Misc. equipment of the Mpl. Board
500.00 from C-77-5(1) Equipment of Municipal Judge
500.00 from C-77-5(2) Equipment of City Attorney
500.00 from C-77-9 Equipment of City Auditor
P 2,088.00 - Total


