Sir:

I have the honor to request your kind attention to
recommend to the Honorable City Board an additional ap-
propriation of P500.00 for the complete construction of
the Artesian Well at Libertad.

Please be informed that there remains a balance of
P92.35 only out of the total National aid of P4,000.00
(Pork barrel of Acting Speaker Veloso) for artesian wells
in Ormoc City.

To leave the project now uncompleted would entail a
loss of time and money by this city because the artesian
well outfit would have to go to Carigara and its return
trip expenses would have to be borne by this city.

Favorable consideration therefore for the appropria-
tion of P500.00 thereof is urgently requested.
