RESOLUTION NO. 60

WHEREAS, the Municipal Board of Ormoc City passed Resolution No. 46 current series thereby appropriating the sum of P1,700.00 to pay the rentals of the houses used for handling classes the same to be taken from Items C-77-5-1 and C-36-t;

WHEREAS, in the letter of the City Treasurer, Ormoc City dated February 29, 1952 addressed to the Municipal Board, Ormoc City, the appropriation for Items C-77-5-1 and C-36-t has already been exhausted in view of the fact that the City Attorney has already ordered legal books and that the appropriation under item C-36-t has already been expended for the construction of Rizal Monument per Resolution No. 175, dated November 21, 1951.

NOW THEREFORE,

The Board, on motion of Councilor Victorino C. Teleron, seconded by Vice Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to amend Resolution No. 46 current series;

RESOLVED FURTHER, to appropriate the sum of P1,940.00; P1000.00 for District I, Ormoc City and P940.00 for Ormoc City High School, Ormoc City to pay for the rentals of the houses presently used for handling classes;

RESOLVED FURTHERMORE, that the sum of P1,940.00 as above appropriated be taken from B-2-9(3);

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; District Supervisor, Ormoc Dist. I, Ormoc City and to the Principal, Ormoc City High School, Ormoc City.






