## RESOLUTION NO. 65

WHEREAS, Mill No. 2195 creating the Municipality of Tugbong, presented by Congressman Domingo Veless, is now under tensideration in Congress;

WHEREAS, said Bill proposed to take the barries of Tugbong, Mentealegre, Tagaytar Libengas Laghalin, Antollo and Masarayas, of the Municipality of Mananga and the barries of Manifilinae, Monterice, Maticaa and San I pacie of Orec City, making the Municipality of Kananga mable to exist as a Municipality because its size will be greatly reduced to compose only the Kananga proper, Rigal, Visares and Lawy;

William in the creation of the new Municipality of Tugbeng would law the the cipality of Kananga only three barries, Rizal, Visares and Londy which would mean the abelition of the Municipality of Yan nta;

WHI TAS, said will will be prejudicial to the City of Ormoc be wise it will reduce considerably the judisdiction of Ormoc City and its revenues;

WHEREAS, said Bill will be prejudicial to the government because it will incur additional expenses, thus adding to the everburdened budget of our gevernment;

WHEREAS, Tugbong is only three kilometers from Kananga along . the read and a distance of one and enchalf kilometers directly from Kananga and that there is no necessity of the creation of such municipality in se short a distance fram a newlu created municipality;

WHEREAR, the creation of the Municipality of Tugbong as proposed in Bill No. 2195 has not originated from the desires of the people of Tugbeng, nor of Kananga, nor of Ormec, all of which are directly affected by such bill;

WHEREAS, there exists me problem of inadequate police protection of these barries proposed to consist the Municipality of Tugbong as metivestated in the prepseed bill presented, and if such preblem ever exists, it is but temperary in nature;

WHEREAS, it will be unfair to proceed to create the Municipality of Tugbeng without consulting the people of Ormoc and Kananga who are directly prejudiced by the previsions of such Bill No. 2195;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Guillerme T. Parrilla;
