RESOLUTION NO. 70

WHEREAS, the President of the Ormoc City Tennis Club Mr. Crispin Mangano being present during the deliberation of the Hon. Body in its regular session held on March 22 and 29, requested the Hon. Body to lease a portion of Lot No. 23 of the Ormoc Cadastre owned by the City Government of Ormoc City to the Ormoc City Tennis Club to be used as tennis court;

WHEREAS, Councilor Guillermo T. Parrilla suggested to the Hon. Body to lease a portion of Lot No. 23 with an area of Nine Hundred (900) sq. m. to the Ormoc City Tennis Club measuring Twenty (20) meters along Burgos St., for a period of ten (10) years at the rate of P1.00 per year subject to the condition that the city government may revoke the same after a period of five (5) years should the city government need it for public improvement;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla seconded by Councilor Ifaki Larragabal;

BE IT RESOLVED, as is hereby resolved, to lease a portion of Lot No. 23 with an area of Nine Hundred (900) sq. m. to the Ormoc City Tennis Club, measuring Twenty (20) meters along Burgos St. for a period of Ten (10) years at the rate of P1.00 per year subject to the condition that the city government may revoke the same after a period of five (5) years should the city government need it for public improvement;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; City Engineer, Ormoc City; the President, Ormoc City Tennis Club.
