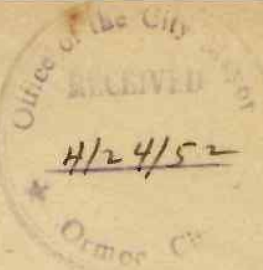

RESOLUTION NO. 77

WHEREAS, be it known that the Ormoc Electric Light Company had cut the 24-hour service;

WHEREAS, be it known further that in offices where electric current is badly needed during the day to operate machines run by electric current were greatly hampered due to the cutting off of said electric current;

WHEREAS, be it known furthermore that Refrigerators, electric iron, machine shops and other mechanical apparatus which are operated by electricity are also hampered due to the abrupt cutting off of the 24-hour service to 18-hour service by the Ormoc Electric Light Company;

WHEREAS, said actions of the Ormoc Electric Light Company have greatly prejudiced several residential houses, hospitals, commercial establishments and offices;

WHEREAS, it is the desire of the Municipal Board of Ormoc City to respectfully request the Manager of the Abaitiz & Company, Cebu City to reinstate the 24-hour service of the Ormoc Electric Light Company at Ormoc City to serve the best interest of the public;

NOW THEREFORE, the Board, on motion of Councillor Victorino C. Teleron, seconded by Councillor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Manager of the Abaitiz & Company, Cebu City to reinstate the 24-hour service of the Ormoc Electric Light Company in order to serve the best interest of the public;

RESOLVED FURTHER, to authorize the City Mayor of Ormoc City to make necessary representation with the Manager of the Abaitiz & Company, Cebu City regarding the aforementioned request;

RESOLVED FINALLY, to furnish copy of this resolution each, to the Manager, Abaitiz & Co, Cebu City; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the Manager, Ormoc Electric Light Company, Ormoc City.

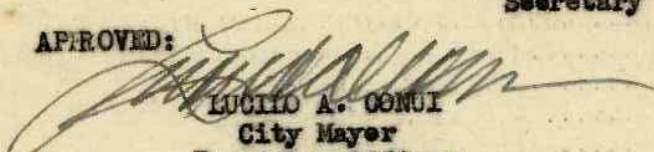
