RESOLUTION NO. 79

WHEREAS, Councilor Esteban C. Ganejos suggested to the Honorable Body to appropriate the amount of P50.00 to cover expenses for installing telephone connection to Camp Dennis and to pay the monthly rentals of said telephone;

BE IT RESOLVED, as is hereby resolved to authorize the Velasco-Leuterio Telephone System to install a telephone connection to Camp Dennis;

RESOLVED FURTHER, to appropriate the amount of P50.00 to cover expenses for the installation of said telephone connection and to cover payment of monthly rentals from April to June, 1952;

RESOLVED FURTHERMORE, that the amount of P50.00 as above appropriated be taken from the per diem savings of the Municipal Board of Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to the Manager, Velasco-Leuterio Telephone System, Ormoc City; Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the Commanding Officer, 3rd "A" Company, Camp Dennis, Ormoc City.
