RESOLUTION NO. 80

WHEREAS, the Municipal Board of Ormoc City, in its regular session held on April 19, 1952 passed resolution No. 78 concentrating the Ormoc City High School at barrio Valencia, Ormoc City;

WHEREAS, the Honorable Body has acknowledged receipt of the petition signed by the PTA President of the City Proper and the Principal and Teachers of the Ormoc City High School, to reconsider the former resolution No. 78 of the Municipal Board, concentrating the City High School at Valencia, Ormoc City;

WHEREAS, be it known that the number of students enrolled at Valencia cannot cope with the minimum requirements of the Bureau of Public Schools;

WHEREAS, Councilor Victorino C. Teleron strongly suggested to the Honorable Body to concentrate the Ormoc City High School at the City Proper so that the said City High School be self-supporting;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Vice Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to reconsider, as it is hereby reconsidered, the former resolution No. 78 adopted by the Municipal Board concentrating the Ormoc City High School at Valencia, Ormoc City; and instead the Ormoc City High School be concentrated at the City Proper;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; Principal, Ormoc City High School; Supervisor, Ormoc Districts I & II, Ormoc City.


