RESOLUTION NO. 81

WHEREAS, the basis for the estimated income of the general fund of Ormoc City in the internal revenue allotment for the fiscal budget of 1951-1952 was the internal revenue allotment of the year 1950-1951;

WHEREAS, the internal revenue allotment of the City of Ormoc for the fiscal year 1951-1952 had been greatly reduced by the Department of Finance due to the understimated revenue collections;

WHEREAS, there had been a decrease of enrolment in the City Intermediate School which considerably reduced the tuition fees collections which should accrue as a portion of the estimated income of the City;

WHEREAS, the City Intermediate School Teachers of Ormoc City who are willing to take summer classes in Manila and other places were not paid for their proportional vacation salary due to the standing overdraft of the School Fund;

WHEREAS, it is the desire of the Municipal Board of Ormoc City to respectfully request the Hon. Secretary of Finance, Manila, to authorize the City Treasurer of Ormoc City to incur an overdraft of an amount corresponding to the proportional vacation salaries of City Intermediate School Teachers who are willing to take summer classes;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Secretary of Finance, Manila, to authorize the City Treasurer of Ormoc City to incur an overdraft of an amount corresponding to the proportional vacation salaries of City Intermediate School Teachers who are willing to take summer classes;
