RESOLUTION NO. 60

WHEREAS, the Municipal Board of Ormoc City passed Resolution No. 60 c.s. appropriating the amount of P1,940 to pay for the rental of buildings used for handling classes of Ormoc District I and the Ormoc City High School;

WHEREAS, said amount of P1,000 for Ormoc District I was not definitely stated as to whether it should be paid for the rental of buildings used for handling classes of both intermediate and primary grades;

WHEREAS, it is the desire of the Municipal Board of Ormoc City to amend said Resolution No. 60 in order that the amount of P1,000 be paid for the rental of buildings used for handling classes of both intermediate and primary grades in Ormoc Dist. I;

WHEREAS, Councilor Guillermo T. Parrilla suggested to the Board to request the City Supervisor of Ormoc Dist. I to make representation to the national government in order that the city government could be reimbursed for the rentals paid for the used of handling classes in the primary grades;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Vice Mayor, Marcelo B. Bandalan;

BE IT RESOLVED, as is hereby resolved, to amend resolution No. 60 c.s.;

RESOLVED FURTHER, to appropriate the amount of P1,940; P1,000 for Ormoc Dist. I and P940.00 for the Ormoc City High School to pay for the rental of Bldgs. occupied by the intermediate and primary grades of Ormoc Dist. I and the Ormoc City High School;

RESOLVED FURTHERMORE, that the amount of P1,940 as above appropriated be taken from B-2-9(3);

RESOLVED FINALLY, to request the City Supervisor of Ormoc Dist. I to make representation to the national government in order that the city government could be reimbursed of the expenses incurred in paying rental of bldgs. occupied by the primary grades;
