RESOLUTION NO. 85

WHEREAS, the Municipal Board of Ormoc City adopted Resolutions Numbers 9 & 18, abolishing certain non-essential positions in the Police Department and Fire Department of Ormoc City, respectively and Resolution Number 25, reverting the appropriation for the salary of the Assistant City Attorney to the General Fund of Ormoc City;

WHEREAS, said resolutions above mentioned were vetoed by the Hon. City Mayor and repassed by the Municipal Board and were again vetoed by the Hon. City Mayor, then sent to the Hon. Executive Secretary, Malacañan Palace, Manila for final decisions;

WHEREAS, it has been published in the daily newspapers that the Hon. Executive Secretary, Malacañan Palace, Manila approved the said resolutions for the benefit of Ormoc City;

WHEREAS, Councilor Esteban C. Conejos strongly suggested to the Honorable Body to respectfully request the Secretary to the Municipal Board of Ormoc City to notify every person affected by said resolutions, that the Municipal Board of Ormoc City will not be responsible for the services they have rendered from the time the resolutions were approved by the Municipal Board or from the time the Hon. Executive Secretary has approved the same;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Iñaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Secretary to the Municipal Board of Ormoc City to notify every person affected by the resolutions abolishing certain non-essential positions in the Police Department and Fire Department of Ormoc City and by the resolution reverting the appropriation of the Assistant City Attorney of Ormoc City, that the Municipal Board will not be responsible for the services they have rendered from the time the resolutions were approved by the Municipal Board or from the time the Hon. Executive Secretary has approved the same;


