RESOLUTION NO. 92

WHEREAS, the old Municipal Board of Ormoc City passed Resolution No. 142, s. 1951, requesting the Director of Public Schools thru the Division Supt. of Schools, Tacloban, Leyte, that the two additional janitorial positions, one in Ormoc District I and one in Ormoc District II be paid from the national government fund;

WHEREAS, said request was disapproved by the Director of Public Schools as contained in his 2nd indorsement dated January 7, 1952;

WHEREAS, it is the desire of the Municipal Board of Ormoc City to request for reconsideration of the decision made by the Director of Public Schools, Manila, to add two additional janitorial positions, one in Ormoc District I and one in Ormoc District II, the same to be paid from the national fund inasmuch as the number of intermediate classes is very much less than the number of primary classes taken care of by the janitors;

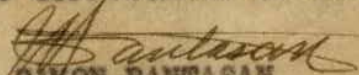
NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Director, Bureau of Public Schools, Manila to add two additional janitorial positions, one in Ormoc District I and one in Ormoc District II, the same to be paid from national funds inasmuch as the number of intermediate classes is very much less than the number of primary classes that said janitors has to take care of;

RESOLVED FINALLY, to furnish copy of this resolution each to the Director of Public Schools, Manila; thru the Div. Supt. of Schools, Tacloban, Leyte; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and District Supervisors, Ormoc Districts I & II, Ormoc City.

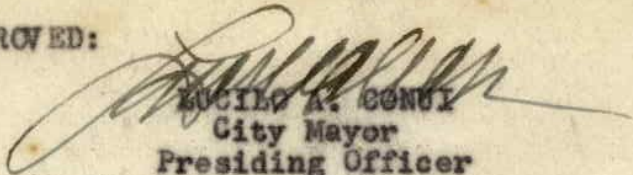
