RESOLUTION NO. 97

WHEREAS, Vice Mayor Marcelo D. Bandalan strongly suggested to the Honorable Body that in order to partially cover up the deficit of the school fund, all the expected unexpended balance of the general fund of Ormoc City will be reverted to the school fund and that the remaining deficit of said school fund will be carried to the next fiscal budget for the fiscal year 1952-1953 as outstanding obligation;

NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councilor Victorino C. Teleron;


BE IT RESOLVED; as is hereby resolved, to revert all the expected unexpended balance of the general fund of Ormoc City to the school fund to partially cover up the deficit incurred by said school fund for the fiscal year 1951-1952;

RESOLVED FURTHER, that the remaining deficit of the school fund not covered by the unexpended balance of the general fund will be carried to the next budget for the fiscal year 1952-1953 as outstanding obligation;
