RESOLUTION NO. 98

WHEREAS, be it known that Mr. Basilio Capuyan, an occupant of a stall in the Public Market, Ormoc City, has requested for the decrease of his rental without the necessary public bidding;

WHEREAS, Councilor Victorino C. Teleron, implementing the provisions of Executive Order No. 298, series of 1940, informed the Honorable Body that the Municipal Board cannot pass a resolution reducing the rental of a market stall - which had previously been submitted for public bidding and awarded to Mr. Basilio Capuyan - without first securing authority from the President, authorizing the decrease of rental without the necessary public bidding;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Vice Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to respectfully request His Excellency, the President of the Philippines that the decrease of the rental of the stall occupied by Mr. Basilio Capuyan be authorized as an exception to the provisions of Executive Order No. 298, series of 1940;

RESOLVED FINALLY, to furnish copy of this resolution each to His Excellency, the President of the Philippines, Malacañan Palace, Manila; the Hon. City Mayor, Ormoc City; the City Treasurer, Ormoc City; the City Auditor, Ormoc City and the Market Superintendent, Ormoc City.
