RESOLUTION NO. 101

WHEREAS, be it known that the Municipal Board passed resolution number 97, c.s. reverting all the expected unexpended balance of the general fund to the school fund of Ormoc City;

WHEREAS, Vice Mayor Marcelo D. Bandalan suggested to the Honorable Body to appropriate the amount of P1,940.00 from the expected unexpended balance already reverted to the school fund, to pay the rentals of the houses used for handling classes by the Ormoc City High School and Ormoc District I;

NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan seconded by Councillor Victorino C. Teleron;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P1940.00; P1000 for Ormoc District I and P940.00 for Ormoc City High School to pay for the rentals of the houses used for handling classes of both primary and intermediate grades of Ormoc District I and the City High School;

BE IT FURTHER RESOLVED, that the amount as above appropriated be taken from the expected unexpended balance of the general fund which had already been reverted to the school fund of Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; City Engineer, Ormoc City; Supervisor, Ormoc District I and the Principal, Ormoc City High School, Ormoc City.
