RESOLUTION NO. 102

WHEREAS, be it known that the Annual Town Fiesta celebration of Ormoc City is fast approaching;

WHEREAS, His Honor, the City Mayor suggested to the Honorable Body that vehicular traffic be suspended temporarily in four (4) city streets facing the plaza viz:

William Bryant Street; from San Vicente to Burgos street; Aviles Street; from Arradaza to Bonifacio street; Arradaza Street; from San Vicente Street to Aviles Street; San Vicente Street; from Arradaza Street to William Bryant Street as recommended by His Honor, the City Mayor;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Vice Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to temporarily suspend the vehicular traffic in four (4) streets facing the public plaza, viz:

William Bryant Street; from San Vicente street to Burgos street; Aviles street; from Arradaza street to Bonifacio street; Arradaza street; from San Vicente Street to Aviles street; San Vicente street; From Arradaza street to William Bryant street as recommended by His Honor, the City Mayor;

RESOLVED FURTHER, to respectfully request the traffic officers of the Police Department of Ormoc City to effect the temporary suspension of vehicular traffic on the four streets aforementioned effective June 26, to July 4, 1952 in order to warn the public, thus avoiding accidents;


