RESOLUTION NO. 103

WHEREAS, the Municipal Board of Ormoc City passed
resolution number 78, c.s. concentrating the Ormoc City
High School at Barrio Valencia, Ormoc City;

WHEREAS, Councilor Victorino C. Teleron strongly
suggested to the Hon. Body that in order to increase
the income of the City High School Fund, Mr. Carlos
Petilla, City High School Principal, be authorized to
receive enrolment in the City proper provided not less
than one hundred fifty paying students will enroll;

WHEREAS, if the enrolment in the city proper will
fall below one hundred fifty paying students, high school
classes in the city proper will not be opened;

NOT THEREFORE, the Board, on motion of Councilor
Victorino C. Teleron, seconded by Councilor Alvaro I.
Gutierrez;

BE IT RESOLVED? as is hereby resolved, to authorize
Mr. Carlos Petilla, Principal of the City High School, to
receive enrolment in the City proper provided not less
than one hundred fifty paying students will enroll;

RESOLVED FURTHER, that if the enrolment in the city
proper will fall below one hundred fifty paying students,
high school classes in the city proper will not be opened;

FINALLY RESOLVED, to furnish copy of this resolution
each to the Hon. City Mayor, Ormoc City; City Treasurer,
Ormoc City; City Auditor, Ormoc City; District Supervisors,
Ormoc Districts I & II; PTA President, Ormoc City and
Mr. Carlos Petilla, Principal, Ormoc City High School;






