RESOLUTION NO. 110

WHEREAS, Councilor Victorino C. Teleron informed the Hon. Body that the City Intermediate Teachers of Ormoc City has not yet receive their vacation salary corresponding for the month of June 1952 in view of the standing deficit of the school fund of Ormoc City;
