RESOLUTION NO. 108

WHEREAS, the Hon. City Mayor of Ormoc City has vetoed Resolution No. 108, c.s. for the reason that it is illegal for the Municipal Board to legislate for the Bureau of Public Schools, but that the Board believe the resolution is not a legislation for the Bureau of Public Schools but only a request to the Division Superintendent of Schools, Tacloban, Leyte;

WHEREAS, many teachers complained that instructions from the Division Superintendent of Schools are wantonly disregarded because teachers are not assigned according to seniority and that applicants are not assigned according to score as shown by the fact that in spite of the fact that many old teachers are not yet assigned, applicants with score below 50 are already in;

WHEREAS, the City Councilors of Ormoc City believe that the Public Schools should be free from political interference so as to raise its standards;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved to over-ride the veto of the Hon. City Mayor on Resolution No. 108, c.s. for the reasons stated above;

RESOLVED FINALLY, to furnish copy of this resolution each to the Director of Public Schools, Manila; Division Supt. of Schools, Tacloban, Leyte; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; District Supervisor of Ormoc I and II, Ormoc City.
