RESOLUTION NO. 119

WHEREAS, the budget was presented late due to unforeseen circumstances that delayed its presentation;

WHEREAS, the approval of city budgets will be delayed due to the many budgets now under study in the Department of Finance;

WHEREAS, our budget will surely be dragging for some time in Manila because of its late submission;

NOW THEREFORE, the Board on motion of Councilor Usualdo F. Laguitan seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, AS is hereby resolved to send a delegation of three members to work for the approval of the budget and all other matters passed by this body that have not been released by the Office of the President;

BE IT RESOLVED FURTHER, that an appropriation of Seven Hundred Fifty Pesos (P750.00) be appropriated for the traveling expenses and other expenses of the said delegation, who will start for Manila immediately after the Mayor shall have approved the appropriation Ordinance for 1952-'53, or shall have vetoed the approved appropriation ordinance whatever it may be.

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City.

VETO OF RESOLUTION NO. 119, CURRENT SERIES
OF THE HONORABLE MUNICIPAL BOARD, ORMOC
CITY, PURSUANT TO SECTION XIV, ART.
III, REPUBLIC ACT NO. 179

The undersigned by virtue of Section 14, Article 3, of Republic Act No. 179, otherwise known as the Charter of Ormoc City, hereby vetoes Resolution No. 119, current series, of the Honorable Municipal Board, Ormoc City, on the grounds hereunder enumerated:

1. It is not shown in the Resolution that previous permission was obtained by the delegation comprising of three (3) members of the Municipal Board to go to Manila, contrary to Provincial Circular Unnumbered dated April 19, 1952;
2. A delegation composed of three (3) members consequently necessitating a larger appropriation, as in this case, for one official trip to Manila is in contravention to the policy of the Board to economize due to lack of funds;
3. If permitted to go to Manila one is sufficient to represent the Board and consequently a lesser appropriation and a bigger saving to the City for future official business of the Board; and,
4. Since the undersigned is going to Manila to work for the approval of the budget, the delegation of the Board is a duplication and will be a strain to the City coffers, which the Municipal Board time and again has abhor taking into account the limited funds for traveling expenses.
