RESOLUTION NO. 125

WHEREAS, Councilor Victorino C. Teleron informed the Hon. Body that there is an aid from the MSA in the amount of ₱1,000,000.00 for the construction of artesian wells and water systems;

WHEREAS, in view of the fact that the Waterworks System of Ormoc City cannot supply enough water for the people of Ormoc City and because Ormoc City has only a few artesian wells, it is the desire of the Municipal Board to respectfully request the Administrator of the M.S.A., Manila, to set aside the amount of ₱50,000.00 as share of Ormoc City for the improvement of the Waterworks System and for construction of more artesian wells;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Iñaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Administrator, M.S.A., Manila, to set aside the amount of ₱50,000.00 as share of Ormoc City for the improvement of the waterworks system and construction of more artesian wells;

RESOLVED FINALLY, to furnish copy of this resolution each to the Administrator, M.S.A., Manila; the Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the City Engineer, Ormoc City.


