BE IT RESOLVED, as is hereby resolved, to appropriate the amount of Twenty Pesos (P20.00) to defray the expenses for the "Greeting Ad" advertisement to be inserted in the Souvenir Journal in the name of the City Government of Ormoc to commemorate the enaugural program of the City Government of Tacloban on October 20, 1952;

RESOLVED FURTHER, that the amount of P20.00 as above appropriated be taken from the unappropriated balance no otherwise appropriated;
