RESOLUTION NO. 122

WH WHEREAS, a mimeograph copy of the proposed bill No. 418 introduced by Senator Eulogio Rodriguez amending certain sections of the National Internal Revenue Code by increasing the participation of Municipalities in certain sources of our national income, was next read;

WHEREAS, said proposed bill No. 418 does not include chartered cities;

WHEREAS, it is the desire of the Municipal Board of Ormoc City to include chartered cities in the proposed bill No. 418 to the effect that chartered cities should be considered both a regularly organized province and a municipality and that the participation of chartered cities in the proceeds of our internal revenue should be a share of both a regularly organized province and a municipality based upon the population;

NOW THEREFORE, The Board, on motion of Vice Mayor Marcelo D. Bandalan seconded by Councilor Victorino C. Teleron;

BE IT RESOLVED, as is hereby resolved to respectfully request Hon. Eulogio Rodriguez to include chartered cities in his proposed bill No. 418 to the effect that chartered cities should be considered both a regularly organized province and a municipality and that the participation of chartered cities in the proceeds of our internal revenue should be a share of both a regularly organized province and a municipality based upon the population.
