RESOLUTION NO. 132

WHEREAS, be it known that the City resident of Ormoc demands the opening of the fourth year class in the Ormoc City High School;

WHEREAS, there are now students waiting for its opening because they cannot be graduated in the private schools this year due to difference in courses offered;

WHEREAS, in order to open the fourth year class at Ormoc City High School it would be necessary to appropriate the amount of P2,000.00 for the purchase of laboratory equipment and supplies to comply with the conditions required by the Division Superintendent of Schools of Leyte;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Usualdo F. Laguitan;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P2,000.00 for the purchase of laboratory equipment and supplies for Ormoc City High School in compliance with the condition required by the Div. Supt. of Schools of Leyte for the opening of the fourth year class thereof;

RESOLVED FURTHER, that the amount of P2,000.00 as above appropriated be taken from out of any amount in the current fiscal budget otherwise not appropriated;

RESOLVED FINALLY, to furnish copy of this resolution each to the Div. Supt. of Schools, Tacloban, Leyte; the Hon. City Mayor of Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City and the Principal, Ormoc City High School, Ormoc City.


