RESOLUTION NO. 131

WHEREAS, be it known that the City High School at
barrio Valencia, Ormoc City had been ordered closed by
the Div. Supt. of Schools, Tacloban, Leyte;

WHEREAS, it is the desire of the Municipal Board of
Ormoc City to respectfully request the Division Supt.
of Schools of Leyte to favorably reconsider his order to
close the City High School classes at barrio Valencia by
closing the same instead at the end of the current school
year; that the supervision of said classes be still placed
under one principal considering the small number of enrol-
ment therein; with the information that the required labor-
atory supplies for general science of the first and second
year high school classes are now complete;


NOW THEREFORE, the Board, on motion of Councilor
Victorino C. Teleron, seconded by Councilor Usualdo F.
Laguitan;

BE IT RESOLVED, as is hereby resolved, to respectfully
request the Div. Supt. of Schools of Leyte to favorably
reconsider his order to close the City High School classes
at Valencia, Ormoc City by closing the same instead at
the end of the current school year; that the supervision
of said classes be still placed under one principal consi-
dering the small number of enrolment therein; with the
information that the required laboratory supplies for
general science of the first and second year are now com-
plete;




